- 1. This invitation for pre-qualification follows the General Procurement Notice for this project that appeared in the Public Procurement Regulatory Authority (PPRA) website and TIE website.
- 2. The Government of Tanzania has set aside funds for the operation of the Tanzania Institute of Education during the financial year 2019-2020. It is intended that part of the fund will be used towards the cost for the Printing and Supply various Textbooks and it intends to apply part of the funds to cover eligible payment under the contract for which this invitation is issued.

- 3. Applications may be made for pre-qualification for one or more of the contracts (lots). The Tanzania Institute of Education intends to pre-qualify Applicants for the contracts. Applicants can apply to be pre-qualified for all lots, but an applicant can be **contracted for a maximum of one lot**. It is expected that invitations to bid will be made in December, 2019.
- 4. Pre-qualification will be conducted through International Competitive Selection Procurement procedures in the Public Procurement Regulations2013 and the Public Procurement (Amendment) Regulations, 2016 and is open to all applicants as defined in the Regulations.
- 5. Interested applicants may obtain further information from and inspect the prequalification documents at the address below in para 8 from 09:00 15:00 hours local time (Monday to Friday) exclusive of public holidays.
- 6. A complete set of pre-qualification Document(s) in English may be purchased by interested Applicants upon submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of TZS 150,000 (Tanzanian Shillings One Hundred Fifty Thousand only). The method of payment shall be to obtain a bill from Tanzania Institute of Education.
